Committee Members in Attendance: (chair) Julie Birkenmaier, Allen Levin, Alan Rowlson, Sonda Thompson, Steve Chodes, Vince Chewning, Jess Stevens, Kelly Harris.

The Meeting was called to order by 6:35 by The Chair Julie Birkenmaier. The chair added the note of the correct spelling of her name. The correction was noted, and a motion was made by Allen L. for approval of the previous minutes, which was seconded by Alan Rowlson. The motion carried.

FPSE Neighborhood SBD

Ashley Johnson from the Park Central Staff addressed the FPSE committee. She gave an introduction/overview of Special Taxing Districts. She explained the two type of districts that are typically established which are an SBD or CID. She gave the requirements for the establishment of each type of district and the community process to undertake for such a cause. There where several questions asked by the committee regarding who initiated this process. Abdul stated that this is a community driven process and must be led and initiated outside of PCDC but Park Central will guide and give technical assistance and facilitate the process with the community. Allen L. gave updated on Chouteau Park. Allen inquired on the status of payment for John Lindell and Cunningham Rec. regarding the removal of the play mounds within the Park. Abdul informed Allen L. that all payment for the Playground should be payed and authorized through the City of St. Louis. Cunningham Rec. did not go through the proper process to authorize the work. Ron Coleman followed up with the process that should have been followed to authorized work. Abdul Stated that he would look to find dollars to cover the cost to keep the project moving but PCDC was not obligated to reimbursed for that expenses. Allen gave an overview of the project of the park and went through the drainage project and the options that are being explored. Ron Coleman discussed the city will look at the project to ensure that the correct option is taken. The committee had a discussion regarding he playground equipment. Several residents on the committee expressed concern over the storage of the equipment or it being stolen or vandalized. Ron Coleman would follow up and regarding he storage or installation of the equipment.

Abdul gave an overview of the funds available for Chouteau Park renovations and projects:

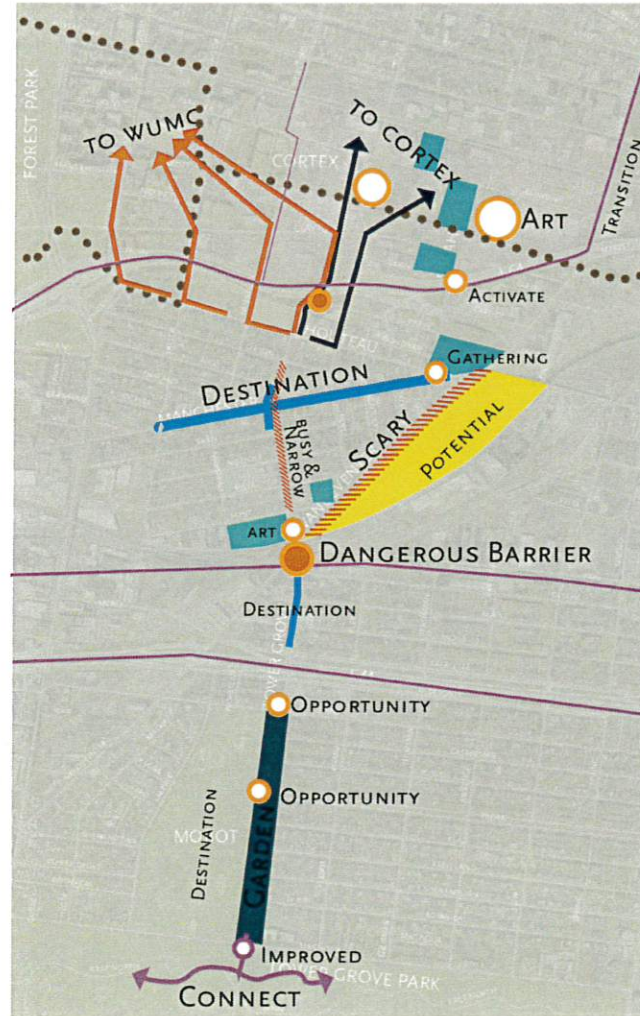
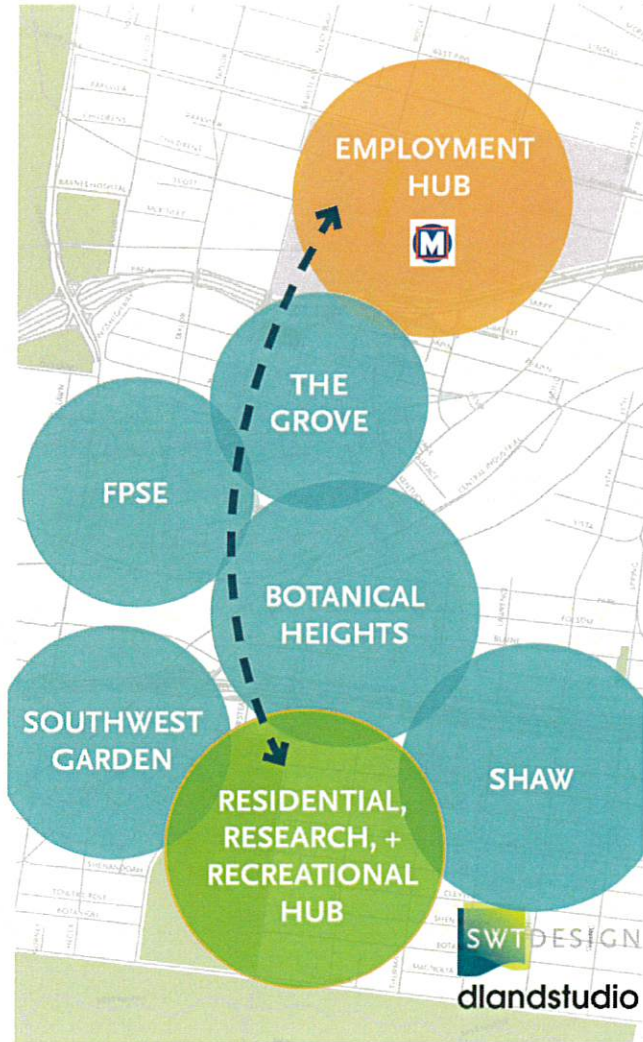

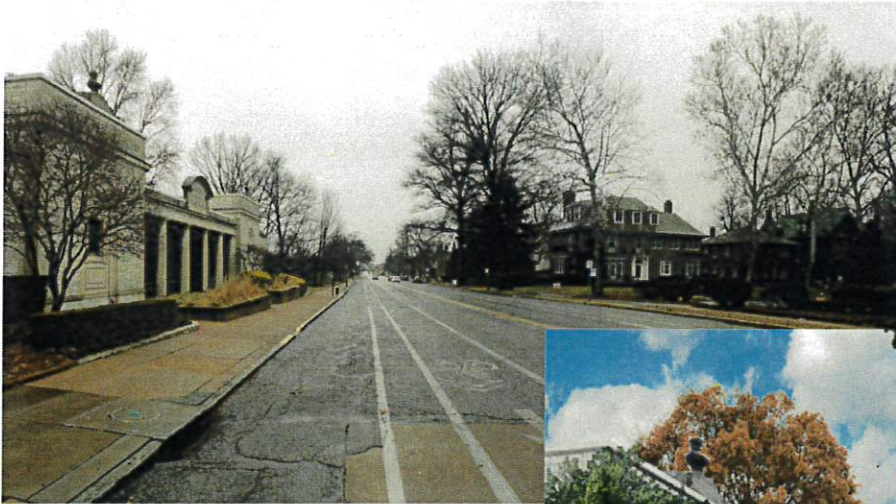

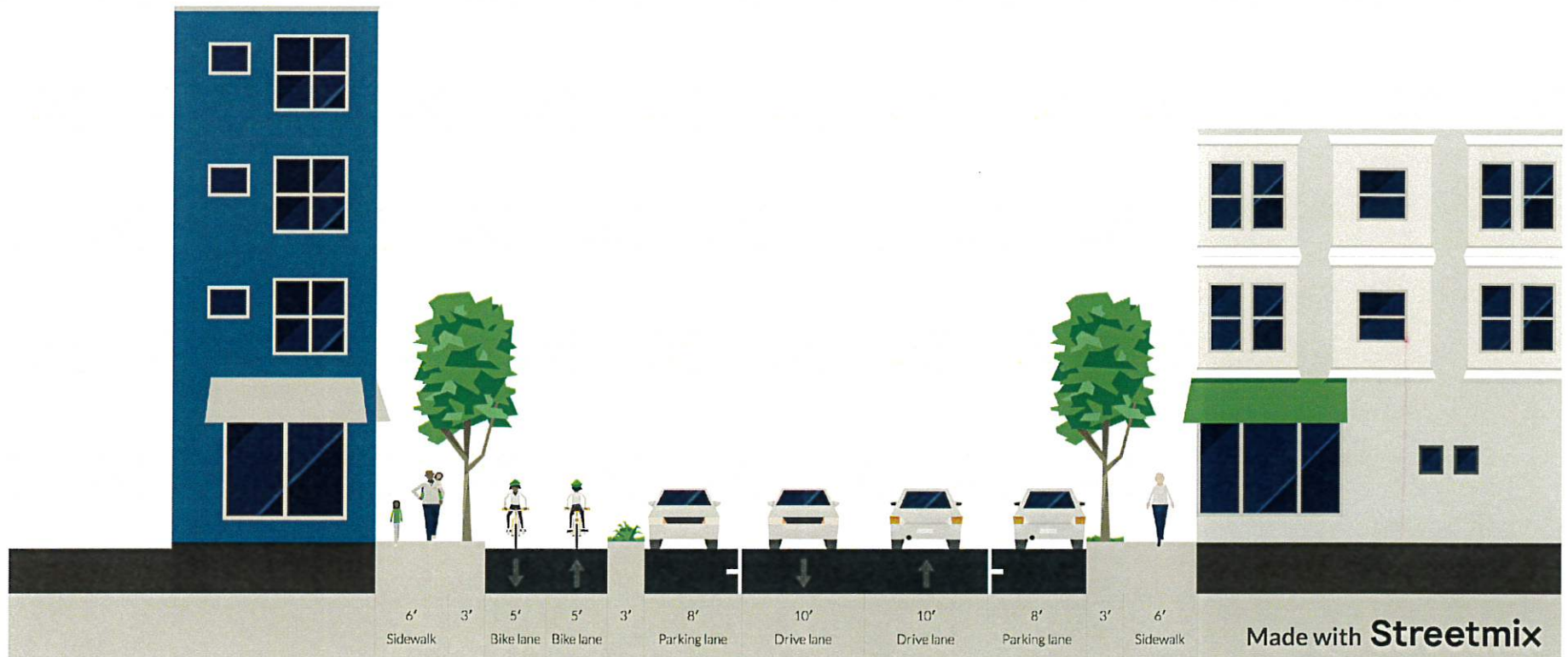
