- They are all off-duty police officers. They sign in every night with the second district and have the same authority as the STLPD.

 - Alderman Roddy was unable to attend.
- 7:30 7:40 pm Community Announcements and Follow-Up (Community, FPSENA Board)
 - Green Street's Unify Grove
 - continue moving forward with wrapping up construction drawings, final cost estimating and pending financing commitments. Same for their progress on the infrastructure plan as coordination between MSD, City Streets, Ameren and ATT is happening just at a slower pace than they'd like. Estimates that they are on target for an early fall construction start for the project based on what they know today while being hopeful that they are past COVID impacts to getting started on the project.
 - PCD's Home Repair Committee
 - o The assembly of the committee has been put on pause
 - The staff will identify folks in need of home repair across neighborhoods
 - National Night Out: Postponed to September or October. Will have social distancing guidelines. If there is anybody interested in volunteering to help organize NNO or join the Hospitality Committee, reach out to the Board.
 - Drury: All developments are on hold.
 - Organized Neighborhood Clean-up
 - Scheduled for June 7. Supplies will be provided.
 - Member: West End Loop Is trying to get a clean going every week
 - Member: Unify Swan Concerned about neighborhood's focus in new rentals over home ownership in the location of Green Street's proposed Unify Swan and Unify Grove developments, and lack of community that rentals bring.
 - Member: Concerned about the material being used and tax abatements for the new 4440 Manchester construction.
