- Bulk pickup is Thursday but should have been out Monday.
- Use dumpsters properly. There is trash in yard waste or boxes or brush just thrown in the alley. City doesn't pick that up, your neighbor does. Try to recycle and remember no plastic bags, even if they have recycle in them!!!
- Call CSB at 622-4800 or go to www.stlouis-mo.gov/CSB with your address if you do not want mosquito spraying which can harm pollinators such as bees and butterflies.
- Tree removals took place last month in the ward and if you have had a tree removed, or would like one planted in front of your home, please send Ron your address. If you want to choose the type of tree Ron will send you a list to choose from.
- Parking meter enforcement begins June 1 again.
- Wear a mask in public and keep a healthy distance, especially from seniors.
- Try to patronize neighborhood businesses that are open. This economy has been really rough on them.
