Guest Speakers

Ward Updates (Alderwoman Pihl)

- Alderwoman Pihl shared that the search for a new police chief will be complete by the end of the year.
- Alderwoman Pihl noted that Kia and Hyundai thefts have remained concerning.
- The mayor will start holding meetings along Delmar regarding safety concerns along that street.
- A consultant has not been chosen for the 17th ward kingshighway study.
- Alderwoman Pihl went on a 'run' with the bulk-pickup crew and noted how heroic our city's refuse drivers are. The refuse department is still actively seeking staff (the city pays \$5-7 less per hour than WM).
- The Armory development received a \$4.6M TIF, Alderwoman Pihl voted no for this tax incentive, but because of no votes a community benefit agreement is under development.
- Alderwoman Pihl plans to initiate a NEXUS study.

The meeting was interrupted by an unvaccinated guest, and that individual was escorted out of the facility

• Coral, Economic Justice Organizer for WEPOWER, shared a presentation on community benefit agreements (CBA).

- WEPOWER is a local non-profit solving our region's biggest systemic challenges by activating community power.
- Four strategies drive WEPOWER toward their goal:
 - 1. Build authentic relationship between everyday people
 - 2. Activate a movement of organizers and public leaders
 - 3. Accelerate community-owned wealth generation
 - 4. Tell human-centered stories that shift beliefs
- The challenge is that black neighborhoods have been stripped of wealth and economic power. The median income in East St. Louis is \$25,000/yr.
- The hope is to negotiate CBAs with developers that provide opportunities such as increased quality, accessible jobs, and the acceleration of generational wealth-building opportunities.
- A city-wide ordinance is the ultimate goal to legally hold developers accountable to give back to the community and require CBAs for developments above a certain size.
