

RESOLUTION FOR THE REFORMATION OF
THE FOREST PARK SOUTHEAST NEWS AND VIEWS

April 19, 1990

Whereas the paper known as The Forest Park Southeast News and Views presents itself as the voice of our community and

Whereas they claim to be concerned citizens of our community but have never identified who those concerned citizens are except for the writers: Karl Chauffe, Mark Jeffries and Richard Sandall and

Whereas they claim to be a not-for-profit group but have never released to the public their Articles of Incorporation, their Bylaws, their Board of Directors nor their Financial Statement and

Whereas they claim they are not political yet they regularly attack the present political leadership of this community while including campaign literature for specific candidates in the paper and

Whereas they regularly attack community leaders and programs which are not political and are working only for the good of our community and

Whereas their articles have become a source of division and bitterness rather than harmony and goodwill in our community:

Therefore let it now be resolved that we, the undersigned, urge The Forest Park Southeast News and View to release its Articles of Incorporation and Bylaws, the names of those who comprise its Board of Directors and its financial statements for 1988 and 1989.

Be it further resolved, for the good of the community, that the Forest Park Southeast News and Views accept into their concerned citizens group any interested citizen of good character and to place on their editorial board an elected representative from each of the five improvement associations in the Forest Park Southeast area in order to reorganize the present policies of the paper and make it a truly representative voice of our community and a positive force which will unite us rather than divide us.
