### Project Description

- **History of Site:** The existing site was given neighborhood approval in 2018 by FPSE Neighborhood Community. The original proposed project was a 90,000-sq. ft. mixed-use development space with Ground floor retail/restaurant consisting of 12,000 Sqft, Second Level parking deck with 47 spaces, Third Level office space with fitness center and outdoor terrace of 18,000 SF
- - Levels 4-6 will be 33 residential units of 1 and 2 Bedrooms
- The top level will be an ancillary piece to the ground floor restaurant with seating and lounge area. There was also a proposed rooftop pool. The site has been vacant for multiple years with several past attempts to develop the site by other development teams.): Site was originally targeted as a traditional mixed-use (residential and retail) building, but given market conditions, it has been postponed.
- Due to pressure from the community and the city, the developer is proposing a temporary use of the space until such times as market conditions are present for a sustainable development.

## Propose Project Information

- The developer is proposing a temporary concept for the site called the sporting Yard: The Sporting Yard will be used as an athletic training facility with a concentration on Soccer. Th site will also offer residents and St.Louis the opportunity to play pick up game in a safe, clean, well lighted and safe space for all ages. Additionally, the sight will be providing a F&B program of snacks, sandwiches and refreshments including beer & wine for adults. This creates a unique opportunity for local residence to meet, play, train, and overall connect with other folks.
- The project will operate its own Food & Beverage concept that will be internal to the property.

## Requested Variances

The project is seeking a use variances to the FPSE Form-Based Code overlay zoning district. The zoning department is classifying the use as an institutional use in the commercial district which Zoned as Neighborhood Center Type 1.
